The operative part of the order reads as under:

"We are of the opinion that a sum of Rs. 15 lakhs over and above that has been granted to the employee/original respondent in terms of the award would be sufficient relief for his illegal termination. Accordingly, we direct the Corporation/employer to pay to the legal representatives of the deceased employee/respondent, who are respondents before this Court the said sum of Rs. 15 lakhs within a period of eight weeks. The order of the High Court impugned in the Civil Appeal arising out of WRIT-A No.48844 of 2016 shall stand modified to the above extent. The award of the Labour Court, otherwise, is held to be legal and valid.

We are passing this order as we find that in fixing compensation adequate discussion was not there as to whether the deceased employee/respondent was gainfully engaged in the interregnum period. We have also taken into consideration that the employee/respondent concerned is no more and is now being represented by his legal heirs and we are inclined to set the matter at rest."

Learned counsel for the petitioner submitted that his client has suffered incarceration for a period of around three years and the charges have not yet been framed. Learned counsel, accordingly, prays that bail may be granted to his client as there is no chance of early conclusion of trial.

Learned counsel for the respondent - State vehemently opposed the prayer for granting bail to the petitioner by stating that the other co-accused who have been granted bail are not attending the court and are not traceable.

Having heard learned counsel for the parties and taking into consideration the fact that the petitioner has suffered incarceration for around three years as also the fact that the other co-accused are on bail and the respondent - State has so far not moved any application for cancellation of bail as against them, we are of the considered view that it is a fit case to grant bail to the petitioner herein subject to the condition that he must attend the trial court everyday during trial without fail. Ordered accordingly.

In case the petitioner fails to appear before the trial court during trial, the bail granted to him today by this Court shall stand automatically cancelled.

The trial court is at liberty to impose any other condition upon the petitioner as it may deem fit.
